NEW STAFF MEMBER

ENTREPRENEURSHIP & BUSINESS

Business Consults

Throughout November, Huron County Economic Development conducted 55 virtual one-on-one business consultations with local entrepreneurs and assisted with two new businesses starting and one existing business expansion, resulting in the creation of three new jobs.

Starter Company Plus

The Fall 2020 intake for Starter Company Plus is officially underway. There are 21 businesses enrolled in the program that will provide support for developing a business plan, access to training on all aspects of running a small business, ongoing support for running your business, and the potential to receive a \$5,000 grant. Virtual pitches will be made in February, and winners announced in March 2021.

Digital Main Street – Digital Transformation Grants

The \$2,500 Digital Main Street Transformation Grant program funds for 2020 have been exhausted. These grants are aimed at helping small Main Street businesses improve their use of digital technologies to promote and run their businesses. We have had 107 businesses apply and 57 receive grant funding to date (many are still pending), resulting in a minimum of \$142,000 grant dollars received in Huron County.

Digital Main Street - Digital Service Squad (DSS)

The Huron County Digital Service Squad are actively working to promote their services to small businesses across Huron County. Throughout December, the three-person team has personally reached out and followed up with almost 600 businesses regarding Digital Main Street program opportunities. We have seen over 225 participants from Huron County engaged in the Digital Main Street 2.0 program.

The DSS team will be available to provide one-on-one support until mid-February 2021. Huron County Economic Development, in partnership with all nine municipalities and the business organizations within them, have received a \$90,000 grant from Digital Main Street Ontario for a Digital Service Squad to help small businesses in the region use digital technologies to adapt to a rapidly changing environment.

Business Workshops & Events

In December, we continued to increase our webinar offerings with business basics, digital marketing and other workshops to round out the year. During the month of December, we had 177 participants in our workshops.

Home Childcare Development Program

Huron County Economic Development continues to work closely with Huron County Children's Services on a program designed to encourage more people to become home childcare providers. The first information session occurred on Tuesday, December 1, 2020, with 14 interested participants. Nine participants decided to carry on with the program and five of those participants have submitted their application to become new home childcare providers for the County. The next intake for this program will happen virtually on Tuesday, January 12, 2021, at 5:00 PM.

BizMap

Huron County Economic Development along with the Huron County GIS team, developed a one-page instruction guide on how businesses can add and edit their listing on the Huron County BizMap. After the lockdown announcement there was an interest from our BIAs, Chambers and Municipal EcDev Partners to have access to this information for their businesses. The document and information was promptly communicated to 1900 contacts, which includes BIAs, Chambers, Municipal EcDev Partners and the business community.

AGRICULTURE

New Agricultural Products

Huron County Economic Development has detailed business plans, with market research and financial projections, for five business opportunities in the agriculture and agri-value add sectors. We are looking to connect with farmers who are interested in diversifying or are seeking additional income streams on their farm.

Five clear business opportunities have been identified that would be well suited to Huron County: hemp (CDB production), maple syrup production, hazelnuts, vineyards, and a small-scale abattoir. We will be holding producer meetings to discuss the hemp opportunity in January and February of 2021. AgPrize

Earlier this year, Huron County Economic Development introduced a challenge question competition, AgPrize 2020, which invites participants to submit their proposals on innovative solutions for the agri-food sector. Strong submissions for each question category are eligible to win a cash prize. All submissions must propose a technically feasible, economically viable solution to the chosen challenge question: Currently farmers are using non-reusable bunker covers to store their feed in. This process is wasteful and can be costly. We need you to find

Huron County Wish Book

The campaign had 82 social media posts over a six-week period, a reach of 68,460 people, 2,111 engagements and almost 2,500 people using the Wish Book. The department received positive feedback from the community and were able to give away \$615 in local gift cards to support the shop local message. The Huron County Wish Book was developed by Huron County Economic Development in partnership with the Bayfield Chamber of Commerce, Blyth BIA, Central Huron BIA, Community Futures Huron, Goderich BIA, Huron County Chamber of Commerce Seaforth BIA, Municipality of Bluewater, South Huron Chamber of Commerce, Town of Goderich, Wingham BIA and the Zurich District Chamber of Commerce.

Following the lockdown announcement to commence Dec 26, 2020, Huron County Economic Development made necessary updates to the COVID-19 resources page on the website. Updates include converting PDF how-to documents into accessible webpages, Online Business Resources, Government & Financial Support for Businesses, Government & Financial Support for Individuals, a Local PPE Supplier List, and webinars links. BizMap

Huron County Economic Development along with the Huron County GIS team, developed a one-page instruction guide on how businesses can add and edit their listing on the Huron County BizMap. After the lockdown announcement there was an interest from our BIAs, Chambers and Municipal EcDev Partners to have access to this information for their businesses. The document and information was promptly communicated to 1900 contacts, which includes BIAs, Chambers, Municipal EcDev Partners and the business community.

AGRICULTURE

New Agricultural Products

Huron County Economic Development has detailed business plans, with market research and financial projections, for five business opportunities in the agriculture and agri-value add sectors. We are looking to connect with farmers who are interested in diversifying or are seeking additional income streams on their farm.



Five clear business opportunities have been identified that would be well suited to Huron County: hemp (CDB production), maple syrup production, hazelnuts, vineyards, and a small-scale abattoir. We will be holding producer meetings to discuss the hemp opportunity in January and February of 2021. AgPrize

Earlier this year, Huron County Economic Development introduced a challenge question competition, AgPrize 2020, which invites participants to submit their proposals on innovative solutions for the agri-food sector. Strong submissions for each question category are eligible to win a cash prize. All submissions must propose a technically feasible, economically viable solution to the chosen challenge question: *Currently farmers are using non-reusable bunker covers to store their feed in. This process is wasteful and can be costly. We need you to find a creative solution for this problem!*

Huron County Wish Book

The Huron County Wish Book campaign successfully wrapped up at the end of December. The campaign had 82 social media posts over a six-week period, a reach of 68,460 people, 2,111 engagements and almost 2,500 people using the Wish Book. The department received positive feedback from the community and were able to give away \$615 in local gift cards to support the shop local message. The Huron County Wish Book was developed by Huron County Economic Development in partnership with the Bayfield Chamber of Commerce, Blyth BIA, Central Huron BIA, Community Futures Huron, Goderich BIA, Huron County Chamber of Commerce Seaforth BIA, Municipality of Bluewater, South Huron Chamber of Commerce, Town of Goderich, Wingham BIA and the Zurich District Chamber of Commerce.
